## TERMS OF 'GENERAL ENGINEERING' WORKS

A 'General Engineering Agreement' must be signed prior to commencement of General Engineering work.

**Note:** 'General Engineering Work' pertains to any work that is not that of a 'Moose Industries' product (Please see our Website for a full product listing). All work, other than the production, maintenance, and warranty of Moose Industries Core Products, is considered 'General Engineering Work'.

**AGREEMENT:** 'General Engineering Work' at Moose Industries requires the 'General Engineering Agreement' form to be signed, before the commencement of any work, including design or any discussions regarding designs, relating to the proposed work.

**NO QUOTATION POLICY:** Moose Industries do not quote on 'General Engineering work'. Moose Industries do not give verbal quotations on 'General Engineering Work'.

- Moose Industries are not required to give "ball-park" figures on 'General Engineering Work'
- If a client requests a verbal "ball-park" on price, Moose Industries will do so at their discretion. If a verbal figure is given, Moose Industries are not liable to hold to that price as pricing will be determined as set out below in this document.
- 'General Engineering work' is always based on a COST PLUS scenario, with no exceptions.
- Any costing or price given verbally by Moose Industries staff upon request by the client is not liable or accurate and it is based on a standard plus or minus 50% variation, but is always determined at invoice by the guidelines set out in this document.

**Example 1.** If a price is verbalised at \$5000.00, this price excludes GST and is subject to a variation of 50% making the price verbalised anywhere in between the range of \$2500.00 to \$7500.00, but will be invoiced at actual COST PLUS, so may vary even more.

**Example 2.** If a price is verbalised at \$10,000.00, this price excludes GST and is subject to a variation of 50% making the price verbalised anywhere in between the range of \$5000.00 and \$15,000, but will be invoiced at actual COST PLUS, so may vary even more.

**LABOUR HOURS:** Labour hours cannot be estimated or determined before completion of the work and will not form part of any verbal estimate. Moose Industries work is high quality and Labour is charged at \$110/hour before GST.

**MATERIALS:** Materials are charged at Industry rates at the time of purchase and are calculated at time of invoice. Our suppliers regularly increase prices without notice based on their own suppliers. We have no control over this.

**COMMENCEMENT CHARGE:** For large jobs or where specialist or large amounts of materials will be required, we may charge a Commencement fee to cover costs of materials up front, this amount will be credited to the final bill.

**CONSUMABLES:** Basic consumables are included in the hourly rate, except when excessive amounts are used for the work. ALL excess consumables will be charged out and will be reflected as "consumables" on invoice.

**INVOICING:** 7 day payment terms upon Invoice paid directly into Moose Industries account VIA EFT
